### July 2017 Request for Expressions of Interest - Projects Approved December 2017

1. **Lower Kananaskis Lake Cottage Subdivision** (Kananaskis Improvement District)

Term of Project – Jan 2018 – Dec 2018

FireSmart Discipline – Vegetation/Fuel Modification

The objective of this project is to treat high hazard areas previously identified in the wildfire mitigation strategy. Thinning of coniferous stems; removal of all dead and down and dead-standing; pruning limbs on residual coniferous, and debris disposal.

2. **Athabasca County Wildfire Mitigation Strategy** (Athabasca County)

Term of Project – Dec 2017 – Sept 2018

FireSmart Discipline – FireSmart Planning

The objective of this project is to develop a Wildfire Mitigation Strategy for the entire area of Athabasca County and the communities within.

3. **Bear Creek Fuel Reduction Project – Phase 2** (County of Grande Prairie)

Term of Project – Aug 2018 – Dec 2018

FireSmart Discipline – Vegetation/Fuel Modification

The objective of this project is to continue treating high hazard areas in the Bear Creek corridor identified in the wildfire mitigation strategy. Thinning of coniferous stems; removal of all dead and down and dead-standing; pruning limbs on residual coniferous, and debris disposal.

4. **Hardisty Creek Fuel Modification** (Town of Hinton)

Term of Project – Jan 2018 – Jan 2019

FireSmart Discipline – Vegetation/Fuel Modification

The objective of this project is to continue treating high hazard areas in the Hardisty Creek corridor identified in the wildfire mitigation strategy. Thinning of coniferous stems; removal of all dead and down and dead-standing; pruning limbs on residual coniferous, and debris disposal.

5. **Ponoka County Community FireSmart Plan** (Ponoka County Regional Fire Services)

Term of Project – Jan 2018 – Dec 2020

FireSmart Discipline – FireSmart Planning

The objective of this project is to develop a wildfire hazard assessment for the entire area of Athabasca County, identifying the communities within that would require further FireSmart planning and mitigation activities.

The objective of this project is to hire a summer crew to conduct FireSmart vegetation management activities within the town of Whitecourt during the summer of 2018. Crews will use town resources to treat areas identified in the Wildfire Mitigation Strategy.

12. **Town of Whitecourt Tabletop Exercise** (Town of Whitecourt)

The objective of this project is to develop a tabletop exercise in response to wildfire response for emergencies involving the Town of Whitecourt. Participants from adjacent response areas will be invited to participate, heightening the awareness of wildfire for all parties involved.

Term of Project – Jan 2018 – Mar 2018

The objective of this project is to develop a Wildfire Preparedness Guide for the entire area of Whitefish Lake First Nation, which will serve as an operational tool for responding to wildfires.

29. **Paul Band First Nation Mitigation Strategy** (Paul Band First Nation)

Term of Project – Feb 2018 – Sept 2018

FireSmart Discipline – FireSmart Planning

The objective of this project is to develop a Wildfire Mitigation Strategy for the entire area of Paul Band First Nation. The plan will outline the hazardous wildfire fuel and identify mitigation activities in response to wildfire threats in the community.

30. **FireSmart Maintenance to Mitigate Mountain Pine Beetle and Forest Regrowth** (Municipality of Jasper)

Term of Project – Dec 2017 – Dec 2018

FireSmart Discipline – Vegetation/Fuel Modification

The objective of this project is to treat high hazard areas identified in the wildfire mitigation strategy, specifically focusing on the presence of Mountain Pine Beetle in the Jasper corridor which resulted in significant wildfire fuel loading in the form of dead standing trees.

31. **FireSmart Summer Student Crew** (Lac La Biche County)
