July 2018 Request for Expressions of Interest – Projects Approved December 2018

1. Regional Mock Exercise (Westlock County)

- FireSmart Discipline: Interagency Cooperation
- Term of Project: December 2018 November 2019
- The objective of this project is to prepare for a wildfire by staging a mock wildfire exercise. This project will determine the capacity of operational coordination between several regional jurisdictions to improve interagency response.

2. Lac La Biche Cross-Training 2019 (Lac La Biche County)

- FireSmart Discipline: Interagency Cooperation
- Term of Project: March 2019 December 2019
- The objective of this project is to provide volunteer on-call firefighters from Lac La Biche County and neighbouring municipalities with mutual aid agreements with two training courses on home assessments and tactical decisions when confronting wildland fires.

3. Gift Lake Metis Settlement Vegetation Management 2019 (Gift Lake Metis Settlement)

- 29. Phases I and II: Maintenance of FireSmart Fuel-Modified Areas to Mitigate Impacts of Mountain Pine Beetle and Forest Re-Growth (Municipality of Jasper)
 - FireSmart Discipline: Vegetation Management
 - Term of Project: December 2019 March 2020
 - The objective of this project is to treat Wildland Urban Interface high hazard areas impacted by the Mountain Pine Beetle surrounding the Town of Jasper. Treatments will include mechanized processing of forwarding, timber salvage on gentle terrain and pile and burn on high angle terrain followed; by ground crews to conduct a final pass.
