Grant Application Process



2 funding opportunities:

- 1) “**Request for Proposals**” for non-vegetation management projects.
 - planning, public education, inter-agency cooperation, cross-training, legislation, and development controls.
 - More information about the FireSmart disciplines can be found on the FireSmart Alberta website <https://firesmartalberta.ca/>
 - applicants submit a detailed proposal

- 2) “**Request for Expressions of Interest**”, followed by an invitational RFP, for vegetation management projects (two-stage).
 - applicants submit an Expression of Interest (EOI)
 - shortlisted applicants are invited to submit a detailed proposal under a Request for Proposal (RFP)

➤ **Funding support is available for Proposal Development**

- Please indicate the requested amount on the EOI or Proposal Application Form. If approved, please submit the consultant's invoice to FRIAA.
- The proposal development fee is separate from your grant funding approval and project expenses. Costs must be reasonable.

➤ **Use of Alberta guidelines and standards are required for grant funding payment.** Deliverables must meet FRIAA and Alberta Wildfire requirements for grant funding payment.

➤ The maximum amount of funding available for a single project is **\$200,000** and project terms are for **one-year**.



Projects prioritized for funding



- **Projects and outcomes must be FireSmart specific.**
- Mitigation of incoming wildfire through multi-stakeholder projects (10-km community zone).
- Examples of eligible activities include targeted public education through schools or community events, table-top exercises, interagency cooperation and cross-training projects.
- FRIAA encourages the use of a FireSmart consultant to prepare your WPG or mitigation strategy (Alberta standard). However, please remember that this is your community plan, so your engagement with the consultant is critical.
- For vegetation management projects, ensure that your proposed treatment area is clearly identified in your existing FireSmart plan.
- When prioritizing your proposed areas for vegetation management, include those surrounding critical infrastructure and values-at-risk. You can find additional information on values-at-risk in the "Guidebook for Community Protection,"

- FRIAA cannot fund prescribed burns. Camps and campgrounds are unlikely to be prioritized for funding.

Elements of a Successful application



- Applicants are responsible for the quality, completeness and relevance of work completed by consultants. If FRIAA / FireSmart standards are not satisfied, grant payments may be withheld.
- For “**Developing a wildfire preparedness guide**”, use the updated 2020 guide.
- FireSmart Plans inside the Forest Protection Area must receive Alberta Wildfire approval on their final draft. For planning projects outside of the Forest Protection Area, discussion with your regional Wildfire Prevention Officer is strongly encouraged.
- The “FireSmart” name and logo are copyright. Information is available on the FireSmart Alberta website. (<https://firesmartalberta.ca/logo-requests/>)
- Home Assessments - fall under public education. Develop a “**per home**” price and commit in your proposal to the number of homes to be assessed.
- Vegetation management projects are required to provide GIS data in the provincial FireSmart data standard.

Application should demonstrate support from your project partners.

➤ **Project Support Letter from FireSmart Provincial Liaison for Alberta – REQUIRED** for Public Education projects with Home Assessments and/or the use of FireSmart branded materials.



➤ **Project Budget:**

- FRIAA looking to see what other sources of funding support will be applied to this project – e.g. direct funds from your community or in-kind resources like existing staff working directly on the project. (Existing staff wages aren't eligible for funding assistance, but this demonstrates your willingness to support the project.)
- In-kind contributions are highly regarded by FRIAA and can include matching cash contributions, project management, quality control, safety training, financial reporting, vehicles, fuel, equipment or hall rentals, printing, tendering, etc.
- **FRIAA FireSmart cannot fund capital asset purchases such as sprinkler kits, iPads, radios or chainsaws.**
- Mark-up of sub-contractor work, contingency or general administration fees will not be approved or reimbursed.
- FRIAA looks for rates to be reasonable and at fair-market value, which can be measured by obtaining competitive bids in your area.



➤ The budget details for the project need to be addressed **in Section 6 of the template.**

Invitation to RFP for Vegetation Management Projects



- Applicants must have a discussion with a Field Representative before submitting their Detailed Proposal.
- The RFP document provides more detailed work plans, budgets, timelines, and reporting schedules compared to the Expression of Interest (EOI).
- Reporting and expense claim schedules may include a funding advance. FRIAA reserves a minimum of 20% of the total funding for the final payment.
- Ongoing projects must be substantially complete before new project approvals will be issued.



➤ **Timeline for non-vegetation management applications are:**

- Submission of proposals **by 4pm, February 13, 2026**
- Successful proposals will be notified by the **end of March 2026**
- Potential project start-up in **April 2026**

➤ **Timeline for vegetation management projects are:**

- Submissions of EOIs due by **4pm, February 13, 2026**
- Short-listed EOIs will be invited to submit a detailed Proposal (notified by **end of March 2026**)
- Submission of detailed proposals by invitation only, tentatively due **May 2026**
- Applicants notified of RFP results by mid **June 2026**
- Potential project start-up in late **June 2026**
